At its most recent School Commission meeting, Kris noted that her evaluations of the teachers, and their self-evaluations will be taking place soon.

In the 2006-2007 school year, the FCE envelope will continue to be sent home weekly, but it will not include the newsletter unless you specifically request a hardcopy of the document. [The same will be true for the PC minutes.]

As of today, the parish is 2% ahead in the weekly collections. A compliance audit will be performed in conjunction with the transition to a new pastor.

The Endowment Board will be meeting on May 22 to discuss the rebalancing of the funds.

School letterhead has been updated. An Annual Report for the 2005-2006 school year will be published in October.

The school budget includes full funding of textbooks, a 4% tuition increase and the funds available for scholarships/financial aid was raised to \$60,000.

The Policies and Procedures committee reviewed the handbook. The tithing and late payment requirements, which have been a part of our handbook, are now being enforced.

The School/Parish Integration committee met and prepared a letter summarizing the survey responses regarding mass. This information will be shared with Fr. John. The "Class of the Month" was implemented to bring up the gifts during the masses.
