- Centennial will be moved from September 2013 to Spring 2014.
- Playground and Capital Campaign Pledge: Commission Members agree to fully support:
  - 1. A three-to-five year Centennial Capital Campaign of approximately \$2,000,000 to meet the expected costs of replacing the large play structure on the playground, roof and window replacement and increasing the Father Mallahan endowment.
  - 2. Increase the goal of the Annual Fund for 2013-14 to \$200,000
  - 3. Families will be approached regarding these three fundraising drives: the Centennial Capital Campaign, the Annual Fund and their parish financial support.
  - 4. School Commission members will be the first approached regarding these fundraising drives.
- **8.** New SC Members for 2013-14: New School Commission Members including Brett Conway, Christine Tobin -Presser, and Terry Burns have been invited and accepted to new four (4) year term.
- **9.** <u>School commission Survey:</u> Amy Huber has drafted an anonymous survey to be sent to all Commission members. Members are asked to self evaluate the School Commission as a group. Responses will be tabulated in aggregate and reported back at the first meeting of the new school year.

- Communication Review: has been completed and presented
- **Technology**: IT assessment is near to completion with recommendation to be forthcoming. Software audit will be conducted in Fall 2013.
